The Kingdom of Cambodia has received a loan from the Asian Development Bank (ADB) toward the cost of Skills for Competitiveness (S4C) Project, and it intends to apply part of the proceeds of this loan to payments under the Contract for DGTVET-W-9 of the Completion of finishing works of Directorate General of Technical and Vocational Education and Training Headquarters.
 2. The Project Management Unit of the Ministry of Labour and Vocational Training (MLVT) now invites sealed bids from eligible and qualified bidders for Completion of finishing works of Directorate General of Technical and Vocational Education and Training Headquarters. The construction period is **3 months** from the contract signing.
 3. Procurement will be conducted through National Open Competitive Bidding Procedures outlined in the Government's Standard Operating Procedures on Procurement for Externally Financed Projects.
 4. This invitation is open to all qualified bidders from eligible source countries of as described in the Bidding Document.
 5. Bidders' attention is drawn to Sub-Clause 6.3 of the Instructions to Bidders (ITB) on the Qualification requirements. Qualification requirements include:
 - ❖ The average annual volume of construction work of the successful Bidder over the last 3 years (2020, 2021 and 2022) shall be at least **USD 838,167**.
 - ❖ Bidders shall demonstrate experience as prime contractor or sub-contractor in the construction of at least two (2) works of a similar nature or complexity equivalent to the works within the last five years with minimum contract price of **USD 314,313** of each contract.
 - ❖ To comply with this requirement, works cited should be at least 70 percent complete, billed and paid and documentary evidence must be submitted with the bid.
 - ❖ The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be: **USD 419,083**.
